A member may purchase a Family Season Card that allows the member's eligible family to use the Blue Lake Springs Homeowners' Association facilities. A Family card may be purchased for \$175.00, which is in addition to the annual assessment. Eligible family members are: parents, grandparents, non-dependent children, or non-dependent grandchildren of the member. Corporations that own property are not eligible. REMEMBER: IF YOU DO NOT HAVE THE ABOVE MENTIONED FAMILY MEMBERS USING THE FACILITY, THERE IS NO NEED TO PURCHASE THE CARD. AS A MEMBER, YOU ARE ALOWED 6 GUESTS (ACCOMPANIED BY YOU) AT NO CHARGE.

The Family Season Card is effective from Memorial Day through Labor Day of the current season. The member MUST provide the Homeowners' Association with the names, ages and relationship of the eligible family members expected to use the card.

The member does not have to accompany the family member to the facility, as long as the family member is in possession of the family season card. However, an adult must accompany children under the age of 14. Prior to entry into the facility, family members using the card are required to show identification at the Recreation Office, as the identification will be checked against the authorized family member list.

If you wish to receive a Family Season Card, please fill out the following information and mail back to the Association office with a check for \$175.00

Names of eligible family members: (Must give first and last names, age and relationship of each eligible member to be listed on card). The Family Season Card entitles the card holder and their dependent children to use the facilities.

| Only 1 card will be issued per family unit. Dependent children must be accompanied by the card holder, unless they are over the age of 14, in which case they must bring their parent's Family Season Card. The Family Season Card holder is allowed two guests per-day without additional guest fees. Any additional guest, above the allowed two guest per-day will be required to pay the current guest fees. *Remember, eligible family members are: parents, grandparents, non-dependent children or non-dependent grandchildren of the member. | |
